We have been approved for the instructional time model that allows us to use remote learning for 50 percent of the school year should that become necessary. SPED services are being accommodated in person and will continue that way. We ask all of our students and staff members to do daily wellness checks prior to coming to school. (b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
